### Potential TENORM

To assist you in determining if the yes or no box should be checked in the yellow area of Section 5 at 5.3, IHD is providing you with the language directly of our solid waste permit:

**K.7. Potential TENORM includes some types of waste from natural gas and crude oil production and transportation wastes, oilfield treatment plants, work-over activities, waste that may contain synthetic proppant, and other waste including but not limited to:**

- a. Accumulated materials including: solids, scale, sediment, production sand, emulsion, sludges and other tank bottoms from storage facilities, separators, heater treaters, vessels, tanks and production impoundments that hold product or exempt waste;
- b. Pipe scale, hydrocarbon solids, hydrates and other deposits removed from tubular goods, piping, casing, filters (including spent filter socks), cleanout traps and other equipment;
- c. Pigging wastes from gathering lines;
- d. Any waste containing or likely to contain synthetic (ceramic) proppant, including, but not limited to, excess materials, spilled materials, flowback materials, and other residues or unused product;
- e. Waste from any treatment plant that accepts and/or processes materials that may contain TENORM;
- f. Materials associated with management or cleanup of Potential TENORM such as rags, gloves, sweepings, protective equipment, pipes, tubing, parts, equipment, hoses, mats, liners, spills or leaks, spill residues and other potentially contaminated materials or mixtures of materials identified in this condition.

All other wastes accepted at the facility are subject to North Dakota Regulations and IHD's Waste Acceptance Plan. Inert waste is also subject to IHD's Inert Waste Segregation and Management Plan. Wastes may be reject for a number of reasons including: failure of the material to appear consistent with the profiling provided to the facility; failure to pass a radiation survey and the presence of free liquids. Acceptance at the facility is also subject to hauler training requirements, licensing and permitting requirements, and adherence to the Department of Health Solid Waste Division Guideline 40 requirements.
